The State Election Commission, Haryana vide notification No. SEC/3E-II/2015/8656, dated 08.09.2015 has issued the election programme for the conduct of elections of Panchayati Raj Institutions in the State of Haryana. In TABLE-C of para 2 of the notification, the list of blocks to be included in 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> phase has been given.

2. District Election Officer (P), Kaithal vide his Memo No. 9172/Panchayat dated 08.09.2015 has submitted that in block Pundri of the district the “Falgu fair” is to be organized from 27.09.2015 to 12.10.2015, the request has therefore been made to conduct the election of the district in two phases only i.e. in 1<sup>st</sup> or 3<sup>rd</sup> phase. District Election Officer (P), Mewat in continuation to his office Memo No. 3848/Panchayat dated 08.09.2015 has further submitted that some public organizations has made the request to defer the elections of 1<sup>st</sup> phase to 2<sup>nd</sup> and 3<sup>rd</sup> phase due to “Islamic Ceremonies (Jalsas)” to be performed on 04.10.2015.

3. In view of the requests of the District Election Officer (Panchayat), Kaithal and Mewat and religious sentiments of the general public, this Commission takes lenient view in the matter and hereby modify the list of blocks of the districts mentioned (Sr. No. 10 & 13 of TABLE-C ) at para 2 as under :-


