ELECTION COMMISSION OF INDIA NOTIFICATION UNDER SECTION 150, 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 (43 OF 1951) FOR THE BYE-ELECTION TO 167-TIRUPATI ASSEMBLY CONSTITUENCY

The following notification of the Election Commission of India, New Delhi, No. 100/AP-LA/1/2015, dated 19th January, 2015/29 Pausa, 1936 (Saka) is published:-

NOTIFICATION

No.100/AP-LA/1/2015: - Whereas, the seat of Sri M. Venkataramana in the Legislative Assembly of the Andhra Pradesh State, elected from 167-Tirupati Assembly Constituency has become vacant on 15th December, 2014, by reason of death; and

Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

Now, therefore, in pursuance of Section 150, Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby: -

- (A) Calls upon the said 167-Tirupati Assembly Constituency in the State of Andhra Pradesh to elect, before the 18th February, 2015 (Wednesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
 - (B) Appoints, with respect to the said election -
 - (a) the 27th January, 2015 (Tuesday), as the last date for making nominations;
 - (b) the 28th January, 2015 (Wednesday), as the date for the scrutiny of nominations;
 - (c) the 30 th January, 2015 (Friday), as the last date for the withdrawal of candidatures;
 - (d) the 13th February, 2015 (Friday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 18th February, 2015 (Wednesday), as the date before which the election shall be completed; and
- (C) Fixes the hours from 7.00 A.M. to 6.00 P.M, as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
