- (A) appoints, with respect to the said election in each of the constituencies, -
  - (a) 26th February, 2015 (Thursday), as the last date for making nominations;
  - (b) 27th February, 2015 (Friday), as the date for the scrutiny of the nominations;
  - (c) 2nd March, 2015 (Monday), as the last date for the withdrawal of candidatures;
  - (d) 16th March, 2015 (Monday), as the date on which a poll shall, if necessary, be taken; and
  - (e) 23rd March, 2015 (Monday), as the date before which the election shall be completed; and
- (B) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken, on the date specified above, for the election.
