PRESS NOTE

1. Special Summary Revision of Electoral Roll w.r.t. 01.01.2018 as qualifying date, has been commenced in all 70 Assembly Constituencies of the NCT of Delhi with draft publication of electoral roll on 23.10.2017. Special Summary Revision-2018 will be carried out in accordance with the schedule prescribed by the ECI as under:

The primary objective of the Special Summary Revision – 2018 is to include newly eligible voters w.r.t. 01.01.2018 i.e. who have completed or will be completing age of 18 on or before date 01.01.2018. Another objective for the Special Summary Revision-2018 is to give opportunities for correction in electors' particulars and also to invite objections against any wrong inclusion in the Electoral Roll.

6. Election Commission of India has also decided that for maximization of registration, improving the fidelity of electoral rolls and to provide better electoral services, a special drive of house to house visits by the Booth Level Officers during the period 15th November,2017 to 30th November,2017 will be conducted in the NCT of Delhi. Further, pilot project of Mobile Based Booth Level ER Management (BLO Net) will also be done during this period in selected Assembly Constituencies.

Any eligible citizen including youth who are completing 18 years on or before 01.01.2018 can file claims in Form-6 for inclusion of their names in the Electoral Roll and any person can file objections to any entries in the draft Electoral Roll at their designated locations in their area of their Constituency between **23.10.2017 to 30.11.2017**.

All existing voters are informed that they can check their details in the Draft Electoral Roll published at the designated locations details of which are available at Chief Electoral Officer, Delhi's website i.e. www.ceodelhi.gov.in and ECI website www.nvsp.in. The forms can also be downloaded from this website.

A Special Drive of house to house visits by Booth Level Officers from 15.11.2017 to 30.11.2017 shall be conducted for maximization of registration, improving the fidelity of electoral rolls and to provide better electoral services during the current Special Summary Revision.

Remember mere possession of EPIC card without any name in electoral roll does not provide Right to Vote. Please check your name in voter list online at www.ceodelhi.gov.in or www.nvsp.in or send SMS to 7738299899 by typing EPIC<space>Voter ID No.

Also note that use of more than one EPIC card is a criminal offence and punishable by imprisonment under the law. In case of possession of more than one voter card, return the other EPIC cards to the concerned Voter Centre immediately and submit duly filled in Form-7 in the Voter centre of your Assembly Constituency for deletion of additional entry.

- ◆ Not Disqualified on any of the grounds viz.
Not a citizen of India or of unsound mind
Declared by any competent court or
Disqualified from Voting due to specified
corrupt practices or offences relating to
Elections.
