BYE-ELECTION TO THE ANDHRA PRADESH LEGISLATIVE COUNCIL FROM KURNOOL  
LOCAL AUTHORITIES' CONSTITUENCY.

The following notification of the Election Commission of India, New Delhi, No.100/AP-LC/9/2017, dated 19<sup>th</sup> December, 2017 / Agrahayana 28, 1939 (Saka) is published:-

#### NOTIFICATION

**No.100/AP-LC/9/2017:-** WHEREAS, the seat of Sri Silpa Chakrapani Reddy in the Legislative Council of the State of Andhra Pradesh, elected from Kurnool Local Authorities' Constituency, has become vacant on 14<sup>th</sup> August, 2017, by the reason of his resignation, before the expiration of his term of office which was upto and including the 1<sup>st</sup> May, 2023; and

WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;

NOW, THEREFORE, in pursuance of sections 151, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) calls upon the said Kurnool Local Authorities' Constituency, in the State of Andhra Pradesh, to elect, before 19<sup>th</sup> January, 2018 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Council of the State;

- (B) appoints, with respect to the said election, –
- (a) the 26<sup>th</sup> December, 2017 (Tuesday), as the last date for making nominations;
  - (b) the 27<sup>th</sup> December, 2017 (Wednesday), as the date for the scrutiny of nominations;
  - (c) the 29<sup>th</sup> December, 2017 (Friday), as the last date for the withdrawal of candidatures;
  - (d) the 12<sup>th</sup> January, 2018 (Friday), as the date on which a poll shall, if necessary, be taken;  
and
  - (e) the 19<sup>th</sup> January, 2018 (Friday), as the date before which the election shall be completed;  
and
- (C) fixes the hours from 8.00 A.M. to 4.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
